LogiCORE™ PRODUCT EVALUATION LICENSE AGREEMENT for CAN Products

THIS LogiCORE PRODUCT EVALUATION LICENSE AGREEMENT for CAN Products is entered into effective as of _____, 20__ (the “Effective Date”) between _____, with an office at _____ as licensee (“Licensee”), and Xilinx, Inc., with an office at 2100 Logic Drive, San Jose, CA 95124 (“Xilinx”).

Note: The CAN (Controller Area Network) protocol is a serial communication link based on the CAN Specification (V. 2.0) developed ROBERT BOSCH GmbH for high-speed in-vehicle network applications.

1. Definitions

(a) “Cores” means the design data, in netlist form, and information relating to the Xilinx CAN LogiCORE product as specified in the Quotation and made available to Licensee subject to the terms of this License.

(b) “Licensed Site” means a geographic location in which Licensee conducts business, with a radius of no more than five (5) miles. The Licensed Site shall be defined as set forth in the Quotation.

(c) “Licensed Materials” means all or any portion of the Cores, together with any design data, documentation, models and/or other materials that Xilinx may furnish to Licensee in connection with this Agreement as set forth in the Quotation.

(d) “Quotation” means the quotation, as shown in *Exhibit A* and incorporated by reference herein. If the parties agree on subsequent Quotations for additional licenses of other materials and/or for additional projects, all such subsequent Quotations shall be governed by the terms of this Agreement. In the event of a conflict between the terms of any Quotation and the terms of this Agreement, the terms of this Agreement shall govern.

2. License Grant. Upon execution of this Agreement, Xilinx hereby grants Licensee a nonexclusive, non-sublicenseable, non-transferable, fully paid-up right and license to use the Licensed Materials at the Licensed Site for the sole purpose of internal testing and evaluation to determine whether the Licensed Materials are appropriate for the design, simulation, implementation and/or manufacture of semiconductor devices to be supplied by Xilinx, but not for any other purposes. Evaluator may make one (1) object code copy of the Cores solely for backup purposes.

In the event that Licensee decides to license the Cores for use in its production design, then Licensee shall execute a separate LogiCORE™ Product Site License Agreement for CAN Products subject to license terms that read, in part, as follows:

“Licensee must, in *Exhibit A*, be identified as belonging to one of the following two categories:

- (1) Licensees using the Licensed Materials for automotive applications, or
- (2) Licensees using the Licensed Materials for non-automotive applications

If Licensee will use the Licensed Materials for automotive applications, then Licensee must use the Licensed Materials solely in Xilinx XA-class devices. Licensee shall order devices referencing ordering codes XAxxxxx-yyyyyylzzzz or XAxxxxx-yyyyyQzzzz (example XA3S1000-4FGG456lzzzz) where zzzz is a CAN device identifier that can be obtained from the local Xilinx sales office.

If Licensee will use the Licensed Materials for non-automotive applications, then Licensee must use the Licensed Materials solely in Xilinx non-XA class devices. Licensee may use the Licensed Materials in up to 20,000 non-XA class devices. If Licensee desires to use the Licensed Materials in more than 20,000 non-XA

class devices, Licensee must contact Robert Bosch GmbH, Corporate Licensing Department for an additional license.

Licensee acknowledges that use of the Licensed Materials in combination with other functionality, software or protocols may require licenses from third parties and Licensee accepts sole responsibility for obtaining such licenses. Licensee further acknowledges that Robert Bosch GmbH ("Bosch") owns patents related to the Controller Area Network ("CAN") which is a serial communication link developed in accordance with the CAN License Specification, as defined by Bosch, and that Licensee shall not modify any implementations of the CAN License Specification, including as contained in the Licensed Materials, without the prior written consent of Bosch."

3. **Restrictions.** Evaluator shall not (i) modify, copy, create derivatives, or translate the Licensed Materials, (ii) merge any portion of the Cores with any other program, (iii) reverse-engineer, decompile, disassemble or otherwise modify the Cores or any components thereof, (iv) transfer, lease, or sublicense the Licensed Materials, or (v) remove any proprietary notices from the Licensed Materials. Use of the Licensed Materials for the manufacture of devices is prohibited without a separate written agreement with Xilinx for such use. Except as expressly set forth in this Agreement, Xilinx reserves all intellectual property rights in and to the Licensed Materials and any copies thereof.

4. **High-Risk Uses.** LICENSED MATERIALS ARE NOT DESIGNED OR INTENDED TO BE FAIL-SAFE, OR FOR USE IN ANY APPLICATION REQUIRING FAIL-SAFE PERFORMANCE, SUCH AS LIFE-SUPPORT OR SAFETY DEVICES OR SYSTEMS, CLASS III MEDICAL DEVICES, NUCLEAR FACILITIES, APPLICATIONS RELATED TO THE DEPLOYMENT OF AIRBAGS, OR ANY OTHER APPLICATIONS THAT COULD LEAD TO DEATH, PERSONAL INJURY OR SEVERE PROPERTY OR ENVIRONMENTAL DAMAGE (INDIVIDUALLY AND COLLECTIVELY, "CRITICAL APPLICATIONS"). LICENSEE ASSUMES THE RISK OF ANY USE OF LICENSED MATERIALS IN CRITICAL APPLICATIONS, SUBJECT ONLY TO APPLICABLE LAWS AND REGULATIONS GOVERNING LIMITATIONS ON PRODUCT LIABILITY.

5. **Ownership.** Xilinx and its licensors, if any, shall retain sole right, title and ownership of the Licensed Materials and all intellectual property rights (including patents, copyrights, trade secrets, and invention disclosures) related to the Licensed Materials, including, but not limited to, any and all improvements, modifications, or derivatives thereof. Nothing contained in this Agreement will be construed as conferring by implication, estoppel or otherwise upon either party any license or other right except the licenses and rights expressly granted hereunder to a party hereto.

6. **Term; Termination.** This Agreement will remain in effect for ninety (90) days from the Effective Date. Licensee may terminate this Agreement at any time by destroying the Licensed Materials and all copies thereof. This Agreement will terminate immediately without notice from Xilinx if Licensee fails to comply with any provision of this Agreement. Upon termination of this Agreement, the licenses, rights and covenants granted hereunder and the obligations imposed hereunder will cease, except as otherwise expressly provided for herein, and Licensee will destroy the Licensed Materials, including all copies and all relevant documentation. The provisions of Clauses 1, 4, 7 ~ 9 and 11 ~ 13 will survive the termination of this Agreement.

7. **Governmental Use.** The Licensed Materials are commercial computer software developed exclusively at Xilinx's expense. Accordingly, pursuant to the United States Federal Acquisition Regulations (FAR) Section 12.212 and Defense FAR Supplement Section 227.7202, use, duplication and disclosure of the Licensed Materials by or for the United States Government is subject to the restrictions set forth in this Agreement. Manufacturer is Xilinx, Inc., 2100 Logic Drive, San Jose, CA 95124.

8. **Limited Remedy and Disclaimer.** THE LICENSED MATERIALS LICENSED HEREUNDER ARE PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESSED, IMPLIED OR STATUTORY, INCLUDING WITHOUT LIMITATION, ANY WARRANTY WITH

RESPECT TO NONINFRINGEMENT, MERCHANTABILITY, OR FITNESS FOR ANY PARTICULAR PURPOSE. Xilinx does not warrant that the functions contained in any of the Licensed Materials will meet Licensee's requirements, or that the operation of the Licensed Materials will be uninterrupted or error free, or that defects in the Licensed Materials will be corrected. Furthermore, Xilinx does not warrant or make any representations regarding use, or the results of the use, of the Licensed Materials in terms of correctness, accuracy, reliability or otherwise.

9. **Limitation of Liability.** XILINX WILL NOT BE LIABLE TO LICENSEE WITH RESPECT TO ANY EVENT OF DEFAULT FOR LOSS OF DATA, PROFITS, GOODWILL OR ANY TYPE OF SPECIAL, INDIRECT OR CONSEQUENTIAL DAMAGES (INCLUDING ANY LOSSES INCURRED BY LICENSEE AS A RESULT OF ANY ACTION BROUGHT BY A THIRD PARTY) EVEN IF SUCH LOSSES WERE REASONABLY FORESEEABLE OR XILINX HAD BEEN ADVISED OF THE POSSIBILITY OF LICENSEE INCURRING THE SAME. THIS LIMITATION SHALL APPLY NOTWITHSTANDING THE FAILURE OF THE ESSENTIAL PURPOSE OF ANY LIMITED REMEDIES HEREIN. NOTHING IN THIS SECTION WILL CONFER ANY RIGHT OR REMEDY UPON LICENSEE TO WHICH IT WOULD NOT OTHERWISE BE LEGALLY ENTITLED.

10. **Export Compliance.** Licensee agrees to adhere to all applicable export laws and regulations, including, but not limited to, those administered by the U.S. Department of Commerce (U.S. Export Administration Regulations 15 CFR 730 *et seq.*), and shall not export, reexport, resell, transfer, or disclose, directly or indirectly, any technical data or products received hereunder, or the direct product of such technical data or products, to any proscribed person, entity, or country, or foreign national thereof, unless properly authorized by the U.S. government.

11. **Third-Party Beneficiaries.** Licensee understands that portions of the Licensed Materials may have been licensed to Xilinx from third parties and that such third parties are intended third-party beneficiaries of the provisions of this Agreement.

12. **Nondisclosure.** Except as otherwise expressly permitted in this License, Licensee will hold in confidence the Licensed Materials and all other information received hereunder from Xilinx. Licensee agrees that the Licensed Materials and documentation furnished hereunder will be treated as proprietary trade secrets of Xilinx, and Licensee will not make the Licensed Materials or the documentation available in any form to any person other than to its employees and to contractors located on its premises with a need to know subject to restrictions no less stringent than those contained herein. Licensee represents to Xilinx that it maintains a system of confidentiality consistent with semiconductor industry standards to protect its own confidential business information, including written agreements with employees, and that the Licensed Materials and documentation will be protected by such a system to the same extent.

13. **Governing Law.** This License shall be governed by the laws of the State of California, without reference to conflict of laws principles; provided, however, if the Licensed Materials are acquired in the European Union (the "EU"), this License shall be governed by the laws of England. Nothing in this License will be interpreted or construed so as to limit or exclude the rights or obligations of either party (if any) which it is unlawful to limit or exclude under the relevant national laws and, where applicable, the laws of any Member State of the European Union which implement relevant European Communities Council Directives.

14. **General.** Licensee may not assign this License or transfer any of the rights or obligations under this License without the prior written consent of Xilinx. This License shall be binding upon, and inure to the benefit of, the successors and permitted assigns of the parties. No addition or modification to this License is valid unless made in writing and signed by both parties. No waiver will be implied from conduct or failure to enforce rights, nor be effective, unless in writing signed on behalf of the party against whom the waiver is asserted. Any part of this License found to be unenforceable shall be enforced to the maximum extent permitted by law and the remainder of this License will remain in full force. This License contains

the entire agreement between the parties relating to its subject matter and supersedes all prior representations, discussions and agreements.
