



Product Discontinuation Notice: Automotive XA7Z030 in FBG484 Package (RoHS 5 of 6)

Product Discontinuation Notice

Overview

The purpose of this notification is to communicate that Xilinx is discontinuing certain XA Zynq™-7000 All Programmable SoC products in FBG484 package. This product discontinuance notice (PDN) applies to both Automotive I and Q temperature grade products.

Description

In an effort to meet EU RoHS 6 of 6 (Restriction of Hazardous Substances) Compliance, Xilinx Automotive products in BDFC (Bare Die Flip Chip) packages including XA Zynq-7000 All Programmable SoC XA7Z030-1FBG484I and XA7Z030-1FBG484Q devices will be switching to completely Pb-Free packaging. The current exemption to the EU RoHS (Restriction of Hazardous Substances) directive allowing lead on internal flip-chip bumps is set to expire in July of 2016. The FBG484 package is being replaced with a new Pb-Free FBV484 package that is fully qualified to AEC-Q100, is fully compliant to EU RoHS 6 of 6, and is available now for purchase. There are no changes to form, fit or function.

This notice should be used in conjunction with previous discontinuance notices which can be found at Xilinx.com.
