Product Discontinuation Notice

Overview

The purpose of this notification is to communicate that Xilinx is discontinuing the Defense-grade PROM 44L Cerquad Package (CC44) products. This product discontinuance notice (PDN) applies to both **Military XQ (M) & (V) temperature grade products**.

Description

Xilinx is transitioning the CC44 packages to a new qualified assembly supplier at Kyocera America. As a result of this transition, Xilinx is discontinuing and replacing current Defense-grade PROM 44L Cerquad Package (CC44) parts with fully compatible 44L Cerquad Package (CK44) parts as shown in [Table 1](#). There is no change to the form, function and reliability of the CK44 package compared to the CC44 package. The package height for the CK44 will be thinner than the CC44 per the package outline drawings.

This notice should be used in conjunction with previous discontinuance notices which can be found at Xilinx.com.
